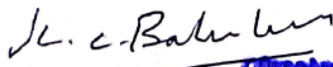
1. Unaudited Financial Results of the Company for Qtr. Ended 30th June 2025 along with Limited Review Report of Auditors as enclosed as Annex B.

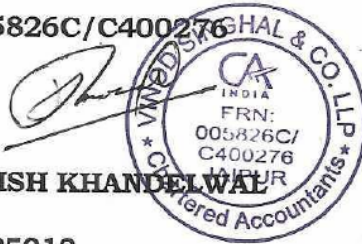
